■ TERMS AND CONDITIONS

1. The client is committed to respect our payment terms of **NET 30 DAYS**. The supplier can consider the sale to be terminated in full right, cease all services in addition to being entitled to collect all amounts due, without consideration of the allowed beneficial terms and this without notice other than a communication of the decision by any means determined. All of which is without prejudice to all other rights.
2. All amounts due to the supplier by the customer cumulate an interest rate of 2% monthly (24% per year), as of terms indicated on invoices by the supplier.
3. If in a situation where the customer would fail to respect any of these terms and conditions and if the supplier should need lawyer services for the protection of its rights or to have them respected, the client is committed to pay to the supplier, an additional fee equivalent to 10% of any owed amount at this time, as liquidated damages, unless a law article or text can exempt the client. This condition will automatically apply in a situation where the account is sent to a collection agency.
4. The client agrees that to any law suit on this contract or towards the services brought as well as the execution of all obligations in virtue of the present contract, both parties will elect Quebec City as its legal residence. The client abandon all rights related to the jurisdiction of the Court other than the Province of Quebec.
5. By this contract, we authorize our financial institution alongside all suppliers doing business with us to disclose all information related to our credit history as part of a credit application request or credit status verification, all of which for an indefinite period of time.
6. Both parties agree on common terms, that the possession of the contract by the supplier as a fax copy completed and signed by the client, constitutes an undeniable proof of commitment, as well as if the supplier had the original copy of the contract.
